her accomplishments were well celebrated on Friday, January 26, 2007 at Leu Gardens in Orlando, Florida. It all began with a 5:30PM Cash Bar and Networking followed with a Dinner and Tributes.

Barbara did not leave FNA without helping to locate a competent person to "walk in her shoes". Barbara worked with Anna Small,

ARNP, CNM, JD who will represent FNA and the nursing profession to the Tallahassee legislators. Before Barbara left, she and Anna lobbied four bills and other issues of importance to nurses. Barbara reports that she and Anna's efforts produced house and senate sponsors for two bills; the one authorizing NP to sign death certificates and a bill placing NPs and Pas in the definition of providers who receive informed consent in Chapter 766, the Florida Medical malpractice Chapter. Senator Durell Peaden and Representative Alan Hays plan to sponsor the "Informed Consent" bill while Representative Ron Saunders and Senator Stephen Wise agreed to sponsor the Death Certificate bill. **Thank you Barbara.** Enjoy your future!

CHARLOTTE COUNTY HEALTH DEPARTMENT PUTS AWAY BLUE TARPS!

Port Charlotte and Punta Gorda are rid of the blue tarps and unsafe facilities following Hurricane Charley on August 13, 2004. The clinics' rehabilitation required 31 months reports Pete Skiba of The News-Press. Eric Stockley, Strategy manager, told various news media that **"over 31 tons of water damaged and outdated equipment has been removed from the site."** Steven Mitnick, M.S., A.R.N.P., MBA Administrator for CCHD told the Charlotte Sun. that "we learned first-hand what the force of a Category 4 hurricane can do to buildings and trees, while at the same time we learned what the force of the human spirit can do to rally a community together." Hurricane Charley devastated the majority of CCHD facilities and delivered a double blow to the residents of Charlotte County as they and their families received services from the health department. Most of the CCHD staff responded (while victims themselves) to the Special Needs shelter caring for some of the vulnerable of the county's population. On Tuesday, January 30, 2007, the Charlotte County Health Department located at 514 E. Grace St., in Punta Gorda had its grand reopening and ribbon-cutting ceremony at its newly renovated facility. The celebration was not for reopening a building stated Mr. Mitnick, but rather "it is to honor and thank all of the people in Charlotte County who continued to work and care for the community despite their personal loss, to all the fine people from across the state who gave of their time unselfishly to help this community, and lastly to say that the guardian of public health is back and stronger than ever in Charlotte County."

Mr. Mitnick described the new design features of the facility : clinical intake offices, exam rooms, treatment rooms and nursing offices. There is a laboratory, conference room and plenty of space for files and audio visual equipment. Mr. Mitnick deliberately reduced the number of administrative offices planned pre-Hurricane Charley to make room for remodeling with a focus on patient privacy. New technology has lead to advanced communication, computerization, and the installation of state-of-the-art client record security system. In March 2007, patients will be seen and receive treatment in the new Punta Gorda facility. Jeanne Wyman, nursing director at the center, said the clinic is looking into accepting private health insurance; patients are currently being seen on a sliding scale based on income. Ms. Wyman stated to news media that the department is in the process of hiring a female nurse practitioner to perform gynecological exams and she mentioned the CCHD performs vasectomy and sterilization procedures. An addition the CCHD offers to clients is the "Dance Dance Revolution" to help promote good exercise. This is a video game in which the players must "dance" by stomping their feet on a game pad in time to the music. Mr. Stockley was reported saying, "It is now time for us to close the book on Charley and look forward to a brighter and better future." Congratulations CCHD and welcome back from the tents and portable buildings.

THE FAPHN VOICE ENTERS LEVEL OF BUSINESS MATURITY PHASE

The Board of Directors approved a motion by Treasurer Kane-Crawford to begin accepting appropriate advertisements for a minimal fee in support of and defraying some of the publishing costs of the newsletter. Gemma’s in-laws reside in Poinciana, Kissimmee areas of Florida. Her desire was to meet and observe American Public Health Nursing at work; with a focus on children’s health and developmental challenges. “How is it done in America?” At the time this issue is going to press, Ms. Taylor is receiving wonderful ‘hands on’ public health nursing exposure from Osceola County Health Department under the leadership of Rose Vince and Susan Crawford. Ms. Taylor promises to submit an article to **The FAPHN VOICE** sharing her educational and mentoring experiences received from Osceola CHD. This is a wonderful opportunity for FAPHN reaching beyond the borders of the State of Florida in meeting its stated mission: *“The Florida Association of Public Health Nurses provides leadership for the nursing profession and promotes quality health care for consumers through education, advocacy, and influencing public health practices in the State of Florida.”*
